to be bred to said stallion for the 2017 breeding season. The Mare Owner and the client presenting said Mare, if different than the owner, agrees to the following:

## Shipped Semen Fees:

1. A \$500 **nonrefundable booking fee** (US dollars) shall be paid to Auld Macdonald Farm Arabians when the Client returns this completed, signed agreement.
2. The total **2017 stud fee**, in the amount of \$1000 (the above mentioned booking fee will be credited toward the total amount) must be paid in full before Legacys Renoir+ is booked for a collection appointment.
3. A **collection fee** of \$300\* is due per collection and payable to **Rogers Bandalero Ranch** in Tucson, Arizona before semen will be collected. Call 520-760-6200 to set up an account. The collection fee includes overnight FedEx charges for the contiguous 48 United States. (\*) Saturday shipment and counter-to-counter air service are also available for additional fees.
4. **Equitainers** are available for use with a \$250 deposit paid to Bandalero Ranch to secure its use. Credit Card information will only be charged if the Equitainer is damaged or not returned.

- Complete and sign this service contract and return with the booking fee.
- Enclose a copy of the mare's registration, complete Mare Information Sheet (see final page) and a copy of any lease agreement, if applicable.
- Collection fees for each shipment **MUST** be paid prior to collection of semen.
- You or your veterinarian must contact **Bandalero Ranch** (520-760-6200) a minimum of 24 hours before semen is needed. We normally can collect 7 days a week if necessary. Two doses are normally sent, but that is at the discretion of Bandalero Ranch.
- We ship via Fed Ex, priority overnight, early morning service, Monday through Friday. Saturday is available with additional Fed Ex charge as is counter-to-counter via air service with additional airline fees. Call **Bandalero Ranch** (520-760-6200) for current fees and details for special shipments.
- This breeding may be transferred to another mare and may be used in the next breeding season **IF MUTUALLY AGREED UPON IN WRITING**.

Payment agreement: Client agrees to pay all fees specified in this service contract. Payment in excess of 10 days later will be subject to a late fee of \$25.00 per month. Clients whose payments are in excess of 30 days past due shall be in breach of contract. Upon said breach of contract by Client, the Stallion Owners and the Auld Macdonald Farm Arabians shall cease further services and retain all funds received to date as liquidated damages. Said damages include, but are not limited to, costs of collection, bookkeeping and lost interest. Registration papers of resulting foal will NOT be signed and released until all monies are paid in full.

Live Foal Guarantee: A live foal is defined as a foal that stands and nurses without assistance. In the event that this mare, or an approved substitute mare, should not produce a live foal a return breeding the following year will be honored. Death of the mare or foal must be certified in writing by a qualified veterinarian within one (1) week of death to obtain a re-breed.

Let it be further understood that the spirit of this agreement is to get the mare in foal to this stallion. The parties to this agreement promise their wholehearted cooperation until breeding is completed.

Special terms: if any:

Complete and sign this service contract, the Mare Information Sheet and return these with the booking fee, and a copy of the Mare's registration and a copy of any lease agreement, if applicable.
